

KAPTIC Membership Pricing

Membership:

- S\$2000 per annum for companies with paid-up capital of above S\$1 million and branch offices;
- S\$1500 per annum for companies with paid-up capital of below S\$1 million and investment funds, venture capital companies, private equity investment companies, trade and investment associations and legal firms;

Premium Membership:

Upgrade membership to Premium Membership at S\$5,000 per annum

Founding Membership:

A one-time payment of USD 100,000 to enjoy our top-tier membership for 99 years (USD 1010 per year on average). This membership will yield extensive marketing, publicity and substantial savings for the member.

Honorary Membership:

Honorary membership is extended to entities or individuals that are of strategic importance to the success of the KAPTIC's mission. The membership is granted on an exceptional basis and strictly by the approval of the Board of Directors (BoD). It can also be revoked by the BoD under extenuating circumstances. Honorary Membership is free and is deemed the highest form of recognition granted by the chamber. Apart from being a prestigious award, Honorary Membership includes all the benefits and privileges provided by the Premium Membership.

Start-up Membership:

S\$250 per annum for start-ups whose business incorporation date is less than three years old.

The Chamber will be using the following yardstick to define start-ups:

- (1) A brand new business which is less than 3 years old;
- (2) Building, developing and/or selling innovative products or services.
- (3) Paid-up capital is less than SGD 100,000
- (4) Requires approval

The regular Chamber membership will subsequently apply when the company reaches its third year of incorporation.
