Terms and Conditions of Membership

1. Should you be approved as a KAPTIC or KAPTIC+ member, you will become a member of **KAZAKHSTAN – ASIA-PACIFIC TRADE & INVESTMENT CHAMBER LTD** (the “Company”), which is a company limited by guarantee incorporated in Singapore.
2. Membership is governed by these terms and conditions as well as the Constitution of the Company, a copy of which will be provided to you.
3. Any prospective member who becomes a member of the Company shall become a member in their name as per in this application form.
4. The membership fees for KAPTIC members is USD 100,000, which is a one-time fee payable within ten (10) working days of approval of membership, such approval would be provided to you in writing. In accordance with paragraph 5 of the Constitution of the Company, KAPTIC members shall guarantee the amount of TEN Singapore Dollars. KAPTIC members shall each have one vote in the general meetings of the Company.
5. The membership fees for KAPTIC+ members is USD 200,000, which is a one-time fee payable within ten (10) working days of approval of membership, such approval would be provided to you in writing. In accordance with paragraph 5 of the Constitution of the Company, KAPTIC+ members shall guarantee the amount of TWENTY Singapore Dollars. KAPTIC+ members shall each have two votes in the general meetings of the Company.
6. In the event any KAPTIC member wishes to upgrade their membership to become a KAPTIC+ member, the desiring KAPTIC member shall submit a request in writing to the Board of Directors and such member undertakes to pay the additional sum of USD 100,000 within ten (10) working days of approval of the upgrade, such approval would be provided to you in writing.
7. KAPTIC+ members are not entitled to downgrade their membership to become a KAPTIC member.
8. Membership fees are subject to change by the Board of Directors of the Company at any time.
9. All membership fees are subject to the prevailing goods and services tax (GST).
10. A member shall not be entitled to the advantages and privileges of membership of the Company until all fees due and owing to the Company has been paid.
11. The Board of Directors reserves the right to reject any application for membership without the need for furnishing any reasons whatsoever.
12. The Board of Directors reserve the right to request for any other additional information from prospective members and/or members.
13. A member shall cease to become a member of the Company if:
 - a. If an individual, the individual is declared bankrupt;
 - b. If an individual, the individual becomes deceased;
 - c. If a company, a resolution is duly passed or an Order of Court of competent jurisdiction is made for the winding up of the company;
 - d. If the member is precluded from carrying on business in Singapore;
 - e. If the member does not pay monies due and owing to the Company within 1 months from the due date; or

- f. If written notice is given to the secretary of the Company and/or the Board of Directors that membership of that member is resigned.
14. Any member who ceases to be a member of the Company shall be liable to pay all arrears of membership fees due by him at the date of so ceasing to be a member.
15. Any proposed change in representative of a corporate member has to be submitted in writing to the Board of Directors of the Company and is subject to the approval of the Board of Directors.
16. If any member in the opinion of the Board of Directors fail to conform to the Constitution, these terms and conditions, or any other published rules and regulations of the Company, or is guilty of conduct derogatory to the dignity of or injurious to the reputation or interests of the Company, the Board of Directors may give notice to such member to resign their membership from the Company within 2 weeks. If the member does not resign by the deadline, the Company may convene a general meeting and/or a directors' meeting to decide whether to expel said member, of which two-thirds majority of members present personally or by proxy shall be necessary for the expulsion of said member.
